**PLEASE TAKE NOTICE** that on May 23, 2018, Governor Phil Murphy signed into law <u>L.</u> 2018, <u>c.</u> 16 (codified at N.J.S.A. 48:3-87.3 to -87.7) ("Act"). The Act requires the New Jersey Board of Public Utilities ("Board") to create a program and mechanism for the issuance of Zero Emission Certificates ("ZECs"), each of which is intended to represent the fuel diversity, air quality, and other environmental attributes of one megawatt-hour of electricity generated by an eligible nuclear power plant selected by the Board to participate in the program. Under the program, the Board may determine the need to issue ZECs to certain eligible nuclear energy generators for the State of New Jersey's energy supply. Those ZECs must be purchased by the state's Electric Distribution Companies ("EDCs"), who in turn may recover the cost of those purchases from customers through a non-bypassable ZEC charge. The Act identifies the steps required to establish this program, including program logistics, funding, costs, application, eligibility requirements, selection process, and the timelines associated with each aspect of the legislation.

On April 18, 2019, the Board determined that the Hope Creek, Salem 1, and Salem 2 nuclear generators ("Hope Creek and Salem Plants") were eligible to receive ZECs during the first eligibility period under the Act, from April 18, 2019 through May 31, 2022.

The second ZEC eligibility period begins on June 1, 2022 and concludes on May 31, 2025. On May 20, 2020, the Board approved Staff's recommendations, provided following a stakeholder proceeding, on future ZEC program requirements and timelines. The Board approved Staff's proposed modifications to the application that the Board will use as part of the process to determine which, if any, nuclear power plants will be eligible to receive ZECs during the second three-year eligibility period. On August 12, 2020, following the receipt of comments on the draft application recommended by Staff, the Board issued an order approving a final form of application, and directing that applications must be submitted by October 1, 2020. In that August 12, 2020 order the Board also directed Staff to retain a consultant to assist Staff in reviewing, evaluating, and providing recommendations on the eligibility and ranking (if applicable) of nuclear power plant applications in the second eligibility period. The Board further directed that the consultant shall aid in the analysis of the ZEC charge, which may be reduced during the second eligibility period under the circumstances set forth at N.J.S.A. 48:3-87.5(j)(3).

On October 1, 2020 PSEG Nuclear, LLC ("PSEG") and Exelon Generation Company, LLC ("Exelon") submitted applications (the "Applications") seeking ZEC certification for the second eligibility period for the Hope Creek and Salem Plants. In subsequent scheduling orders the Board established a procedural schedule, calling for the issuance of preliminary findings by the Board Staff's consultant on January 15, 2021; the public hearings described in this Notice, to take place on February 1, 2021; evidentiary hearing, to take place the week of March 8, 2021; and Board Action on the Applications, to take place on April 27, 2021.
