1. Cablevision is a cable company as defined under the provisions of the New Jersey Cable Television Act, N.J.S.A. 48:5A-3(g), and is the current holder of a Certificate of Approval issued by this Honorable Board on September 9, 1997, for the construction, operation and maintenance of a cable system in the Township of Edison (hereinafter "Township"), County of [01483612,DOC;1]

Middlesex, State of New Jersey. The Certificate of Approval expired on January 31, 2003.
