Dear Ms. Izzo:

First Communications, LLC submits to the New Jersey Board of Public Utilities an original and five (5) copies of amended Sheet Nos. 2, 50, and 51 to First Communications, LLC's ("First") New Jersey switched access tariff, New Jersey Tariff No. 2, for incorporation into the Company's Tariff.

This submission is made pursuant to the Federal Communications Commission's ("FCC") *Report and Order and Further Notice of Proposed Rulemaking*, in Docket Nos. WC Docket No. 10-90, et al., FCC 11-161,<sup>1</sup> *Second Order on Reconsideration* in Docket Nos. WC Docket No. 10-90, et al., FCC 12-47,<sup>2</sup> and Sections 51.911 and 61.26(c)<sup>3</sup> of the FCC's rules, 47 C.F.R. §§51.911, 61.26(c).

On June 16, 2015, The Verizon Telephone Companies ("Verizon") amended Section 6 of their Tariff F.C.C. No. 1, *inter alia* reducing the Composite Terminating End Office Charge. First complies with the above cited orders and rules by reducing its terminating intrastate access rate and intrastate Toll VoIP-PSTN traffic rates through adoption of the corresponding The Verizon Telephone Companies' amended terminating access rates set forth in The Verizon Telephone Companies' Tariff F.C.C. No. 1, effective July 1, 2015. The Company's F.C.C. Tariff No. 3 may be viewed at <https://apps.fcc.gov/etfs/public/lecTariffs.action?idLec=484>. A July 1, 2015 effective date is requested to enable the Company to comply with the above cited orders and rule.


