Dear Secretary Asbury:

Pivotal Utility Holdings, Inc. d/b/a Elizabethtown Gas ("Elizabethtown" or "Company") hereby submits this letter petition by which it requests the Board of Public Utilities ("Board") to issue an order permitting Elizabethtown to provide a bill credit to its customers to enable the Company to refund its estimated Clean Energy Program ("CEP") overrecovery balance of \$6.9 million. Elizabethtown respectfully requests the Board to act on this request at its earliest convenience.

The CEP was created through the Electric Discount and Energy Competition Act in an effort to promote energy efficiency and renewable energy programs by offering financial incentives, programs and services to New Jersey residents. Elizabethtown assesses a CEP rate as a component of its Societal Benefits Charge to enable the Company to recover its allocated share of the costs of the CEP.

Elizabethtown's current CEP rate is \$0.0244 per therm. Elizabethtown filed a petition on July 18, 2014 in Docket No. GR14070755 seeking to reduce its CEP rate from \$0.0385 per therm to \$0.0244 per therm. Elizabethtown's proposed rate was approved by Order dated February 11, 2015 and became effective February 23, 2015.¹ Because of the passage of time

between the filing of the current CEP rate and its effectiveness, Elizabethtown estimates it will have a CEP overrecovery balance of \$6.9 million as of June 30, 2015. The Company submits that it would be in the public interest for Elizabethtown to refund this overrecovery balance to its customers at this time by means of a bill credit. Elizabethtown proposes to determine each customer's credit on the basis of historical usage for the 12 month period ending June 30, 2015. Using this methodology the Company estimates that this will result in a total credit of \$14.00 to a residential heating customer that used 1,000 therms during the period ending June 30, 2015.

Elizabethtown requests the Board to grant such waivers of its regulations as may be necessary to accept this letter petition and to approve this request as expeditiously as possible. Elizabethtown plans to make its annual filing to update its CEP rate in July 2015² and would like to receive approval to make the refund before revising its CEP rate so that it can propose a CEP rate that will reflect the Company's best estimate of its ongoing CEP cost responsibility. Elizabethtown is authorized to state that the Division of Rate Counsel does not object to this proposed refund subject to its right to review the appropriateness of the refund in the proceedings concerning the CEP filing that the Company will make in July 2015.
