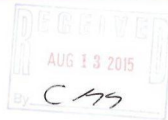

VERIFIED PETITION

Comcast of New Jersey II, LLC (hereinafter "Comcast" or "Petitioner"), hereby petitions the Honorable Board of Public Utilities (the "Board"), pursuant to 47 U.S.C. §546(c), N.J.S.A. 48:5A-15, -16 and -17, N.J.A.C. 14:17-6.9 and N.J.A.C. 14:18-13.1 *et seq.*, for renewal of a Certificate of Approval. In support of its Petition, Petitioner states as follows:

COUNT ONE

1. Comcast, a limited liability company duly organized under the laws of the State of Delaware, is a cable television company subject to the jurisdiction of the Office of Cable Television ("OCTV") and the Board, pursuant to N.J.S.A. 48:5A-1 *et seq.*

2. Comcast maintains its principal offices at 800 Rahway Avenue, Union, New Jersey 07083.

3. On or about August 3, 1979, pursuant to N.J.S.A. 48:5A-17(a) and (b) and N.J.S.A. 48:5A-28(c), the Board issued a Certificate of Approval in Docket No. 796C-6487 to Suburban Cablevision ("Suburban") to provide cable television service in the Township of Cranford ("Township" or "Cranford"). A copy of said Certificate of Approval is on file with the OCTV.

4. On or about December 5, 1990, pursuant to N.J.S.A. 48:5A-17(a) and (b), the Board issued a Renewal Certificate of Approval to Suburban in Docket No. CE89120988 to provide cable television service in Cranford. A copy of said Certificate of Approval is on file with the OCTV.

5. On or about November 30, 1994, pursuant to authorization granted by the Board in its Order of Approval in Docket No. CM94080365, Suburban became a wholly-owned indirect subsidiary of Comcast Corporation; Suburban subsequently changed its name to Comcast of New Jersey II, LLC, Petitioner herein.

6. On or about April 19, 2000, pursuant to N.J.S.A. 48:5A-17(a) and (b), the Board issued a Renewal Certificate of Approval to Petitioner in Docket No. CE99120911 to provide cable television service in Cranford. A copy of said Certificate of Approval is on file with the OCTV.

7. On or about June 10, 2002, pursuant to N.J.S.A. 48:5A-17(a) and (b), the Board issued an Order of Amendment of a Renewal Certificate of Approval to Petitioner in Docket Nos. CE99120911 and CE 02040255 to provide cable television service in Cranford. A copy of said Order is on file with the OCTV.

8. Pursuant to N.J.S.A. 48:5A-1 et seq. and N.J.A.C. 14:18-13.3(a)3, on or about October 29, 2013, Petitioner submitted an Application for Renewal of Municipal Consent (hereinafter the "Municipal Application") to continue to construct, operate and maintain a cable television system ("System") in the Township.

9. On or about January 13, 2014, a public hearing was held by the Township with respect to Petitioner's Municipal Application, during which all interested persons desiring to be heard were so heard.

10. On or about May 19, 2015, the Township adopted Ordinance No. 2015-20 (the "Ordinance") granting to Petitioner renewal of its Municipal Consent ("Renewal of Municipal Consent") to continue to construct, operate and maintain the System in the Township. A copy of the Ordinance is annexed hereto as Exhibit A.

11. On or about June 2, 2015, Comcast filed its formal acceptance of the terms and conditions of the Renewal of Municipal Consent granted by the Township, pursuant to N.J.S.A. 48:5A-24. A copy of said letter of acceptance is annexed hereto as Exhibit B.

12. The information pertaining to Petitioner on file with the OCTV, together with the information contained in its Application for Renewal of a Certificate of Approval ("COA Application"), simultaneously submitted herewith, all of which is adopted by reference thereto, establishes the requisite criteria for the continued construction, ownership, operation and management of the System in Cranford by Comcast.

13. Comcast possesses the requisite character and suitability for the continued operation of the System. Further, as indicated in the COA Application and other information on file with the OCTV, Comcast possesses the necessary financial integrity and the ability to perform efficiently the proposed services and those services which may be required by the public convenience and necessity during the renewal period. The public convenience and

necessity generally support the appropriateness of the issuance of a Renewal Certificate of Approval to Petitioner.

14. Petitioner has complied, and will continue to comply, with all rules, regulations and laws applicable to the construction, operation and maintenance of the System and will continue to provide safe, adequate and proper cable television service in the Township of Cranford and the other municipalities in which it serves.

COUNT TWO

15. Comcast repeats paragraphs 1 through 14 of COUNT ONE as if set forth fully hereinafter.

16. As set forth in the Municipal Application, the COA Application and other information on file at the OCTV, the System operated by Comcast in the Township is part of larger regional Comcast and Comcast-affiliated cable television systems serving numerous other municipalities contiguous to and surrounding the Township.

17. As also set forth in the Municipal Application, the COA Application and other information on file at the OCTV, the Township represents an integral part of the Comcast and Comcast-affiliated regional cable television systems serving the counties of Essex, Hudson, Middlesex and Union. In addition, the demographics of the Township, as well as its location and other factors, mandate that cable television service be provided by Comcast as part of Comcast's and its affiliates' regional systems.

18. The Township portion of Comcast's and its affiliates' Essex, Hudson, Middlesex and Union County regional cable systems is necessary for the continued provision of safe, adequate and economical cable television service to the citizens and residents of the Township and the larger cable television systems generally. Further, continuation of Comcast's

WHEREFORE, it is requested that this Honorable Board of Public Utilities issue to Comcast of New Jersey II, LLC, a Renewal Certificate of Approval to continue to construct, operate and maintain a cable television system in the Township of Cranford.
