Dear Secretary Asbury:

In accordance with the New Jersey Board of Public Utilities ("Board") August 19, 2015 "Decision and Order Approving Provisional CEP Refund" ("August 19 Order") issued in the above-referenced proceeding, Pivotal Utility Holdings, Inc. d/b/a Elizabethtown Gas ("Elizabethtown" or "Company") is providing written notice to the Board and the New Jersey Division of Rate Counsel of its intent to issue a lump sum bill credit with billing cycles beginning on October 1, 2015 to customers subject to the Clean Energy Program ("CEP") component of the Societal Benefits Charge ("SBC") rate. As reflected in the August 19 Order, this bill credit is being issued in order to refund the Company's over-recovered CEP balance. The bill credit will be based upon each customer's individual gas usage for the twelve (12) month period ending June 30, 2015 and will result in a total credit of \$14.00 for an average residential heating customer using 1,000 therms.
