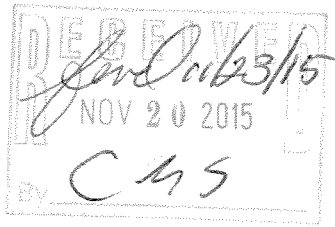

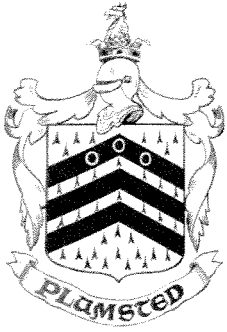

As a result of that bid process, the Township awarded a contract to TriEagle Energy, for a 21-month contract beginning in March of 2016. The new power supply contract with TriEagle will start in March because the Township received significantly better bid prices for a March 2016 contract start date as compared to the bids for a November 2015 start date. As a result, residents previously served by the PCEA program will be temporarily transitioned back to JCP&L power supply service at the default tariff price in November of 2015, will remain on JCP&L default supply for several months, and will be enrolled for service with TriEagle starting with your March 2016 meter reading date. Residents currently receiving power supply from JCP&L will remain on JCP&L power supply until March.

TriEagle will provide electric supply at a non-variable rate of \$0.08752 per kWh for a 21-month term from March 2016 to December 2017. The contract is expected to save the typical Township resident about \$14 per month, or nearly \$300.00 over the contract term, with no change to the level of service. TriEagle is a licensed retail electric supplier in New Jersey since 2011 and is currently serving over 60,000 residential customers state-wide. 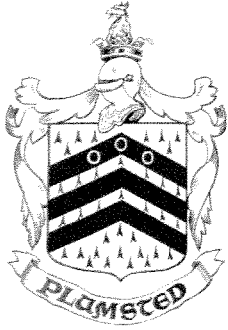

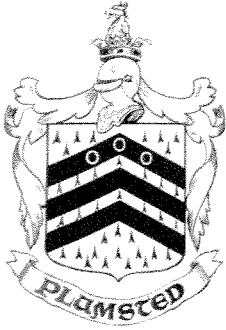
