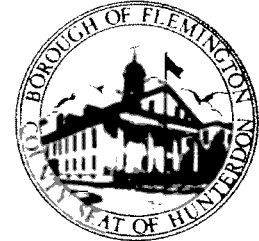

This Program is designed to save residents money on their monthly electricity bills. This Fall, the Municipalities combined the load of all residential customers and sought competitive bids from licensed suppliers to provide electric supply service. After a competitive contracting process and extensive evaluation, the Township and Borough accepted bids and awarded a contract to the low bidder, TriEagle Energy, LP.

The Township and Borough are pleased to inform you that TriEagle Energy, will supply power to FR CEA participants for a 21-month contract beginning in March 2016. The contract with TriEagle will provide electric supply at a price of \$0.08667 per kwh, which represents a savings of nearly 15% as compared to the average JCP&L tariff price of \$0.1018/kwh. The contract is expected to save the typical resident over \$13 per month, or about \$270 over the 21 months, with no change to the level of service. Total aggregate savings for Township and Borough residents are estimated to be nearly \$2 million.

TriEagle is a licensed retail electric supplier in New Jersey since 2011 and is currently serving nearly 65,000 aggregation residential customers state-wide. If you do not wish to participate in the FR CEA Program, please follow the opt-out instructions provided in the Program Summary on the reverse side of this Notice. 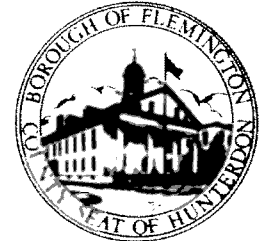

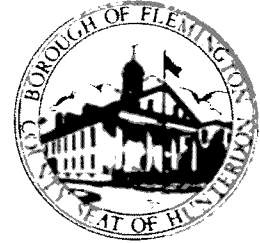
