Re: Corporate Name Change of the United Water Inc. Companies

Dear Secretary Asbury:

As of November 9, 2015, the United Water Inc. companies (the "Companies") have changed their operating names (and tariffs) to SUEZ, the ultimate corporate parent of United Water. Therefore, the following matters currently pending before the Board of Public Utilities (the "Board") should reflect this corporate name change in their captions. I am authorized by SUEZ to communicate these changes to you, regarding both the matters in which we represent the Companies and matters in which the Companies are represented by other counsel.

Since the effective date of the name change, the Companies have been using the new name on documents formally filed with the Board. I have attached a copy of our letter dated November 12, 2015 indicating those corporate name changes. This letter is simply meant to ensure your records reflect the correct captions. We are providing extra copies of this letter for your convenience in populating those files. The case captions which are subject to revision are set out below:
