Please allow this letter to acknowledge receipt of the filing fee and the required number of copies of the application of National Association of African American Owned Media "(NAAAOM") and Entertainment Studios Networks, Inc. ("ESI") for emergent relief and a stay of the Board's Order dated March 31, 2016 in the above-captioned matters. The filing fee and required copies were received on May 12, 2016 and therefore your matter is deemed docketed as of that date.

In order to afford the responding parties appropriate due process, this letter advises that responses shall be due within ten (10) days of the date of filing. Since May 22, 2016 falls on a Sunday, responses may be filed up to and including Monday, May 23, 2016. Due to the intervening legal holiday, any reply by NAAAOM and/or ESI may be filed on or before Tuesday, May 31, 2016. Any requests for extension of those deadlines should be made in writing to this office with a copy to all parties of record. All moving and responsive pleadings will thereafter be provided to all Commissioners for their review, consideration and determination. The matter will be placed on a Board Agenda, made available to the public, when the Board is prepared to vote on the matter. As explained in my telephone conversation with your associate on May 12, 2016, there is no public comment portion at the BPU Board meetings. The meetings are open to the public pursuant to N.J.S.A. 10:4-12; there is no statutory or legal obligation to provide for public comment during the meetings and the Board has not authorized such a practice. Comment is welcome during the pendency of any matter, as it was in the above-captioned cases in both the BPU proceedings and the FCC proceedings. Your letter indicates that you also wish to "argue in favor of [your] emergent request." Any additional argument you wish to make in support of your application should be forwarded in your filings with the Board, which, as stated above, will be considered by all Commissioners at the appropriate time. If you need further time to submit additional argument beyond what the briefing schedule above allows, please simply make a written request to the Board with copies to all persons on the service list.

For any and all future correspondence and filings with the Board, please be sure to serve all parties of record listed on the Board's Order dated March 31, 2016, including the Office of the Secretary at the BPU. Your letter of May 13, 2016 to DAG Caroline Vachier was not copied to the Board. Your letters dated May 11, 2016 and May 12, 2016 do not reflect that they were served on the Division of Rate Counsel and it is requested that you please do so. Please also make service of any other previously-filed correspondence or pleadings which have not been made on all parties of record. Due process is not afforded to all parties if all parties do not receive copies of all filings and correspondence.
