The Board of Public Utilities (BPU) is proud to announce the launch of our e-Filing program. E-Filing can be used for Case Management, Customer Assistance, Pipeline Safety, One Call and Cable Television. It is fully integrated with our new internal Case Management System for seamless document review and processing.

E-Filing requires no software installation, is accessible from any computer with internet access, and has no additional filing costs. It will also reduce the need for numerous copies. Those that chose to e-File will be exempt from the regulatory requirement of filing ten (10) hard copies with the Board Secretary. We do ask that two (2) clearly marked "courtesy" copies be sent regular mail to NJBPU's Division of Case Management.

E-Filing via the MyNewJersey Portal is available 24/7, 365 days a year to file petitions, responses, compliance documents, exhibits, briefs and more.
