



- (ii) the availability of sufficient funds to fund all outstanding network extensions, rebuilds, upgrades or other construction commitments arising from such cable television system's Primary Service Area, Certificates of Approval, municipal consents, letters of intent or other orders or similar agreements, including but not limited to the Board Order in Docket No. CO15091102 and documentation provided subsequent thereto;
- (iii) the availability of billing records to all customers of such system, the Board and the Office of Cable Television & Telecommunications for three previous years in accordance with N.J.A.C. 14:18-3.7; and
- (iv) compliance with Emergency Alert System ("EAS") obligations imposed by the Federal Communications Commission on digital programming services, effective December 31, 2013, and the retention of the current levels of EAS functionality as provided or otherwise required under the State Operational Plan.

Pursuant to the request of the Office of Cable Television & Telecommunications, this letter also confirms the grant to Petitioners of an extension of time of thirty (30) days within which to submit a Certification regarding part b) of ordering paragraph 23, pertaining to requirements or conditions arising out of Board Offers of Settlement and Certificates of Approval.

I, Adam Falk, being of full age, hereby certify as follows:

1. I am Senior Vice President, Government Affairs, of Charter Communications, Inc. ("Charter"), a Petitioner in the above-captioned matter.


2. On May 18, 2016, Time Warner Cable New York City LLC ("TWCNYC") became a wholly-owned, indirect subsidiary of Charter. TWCNYC operates a cable television system in the State of New Jersey, commonly known as and referred to the "Bergen System". I am generally familiar with the operation of the Bergen System.

3. On March 31, 2016, the Board of Public Utilities ("Board") issued its Order Approving Stipulation of Settlement in Docket Nos. CM15070770 and TM15070772 (the "Order"). The Order sets forth certain enumerated conditions with respect to the Board's approval of the then proposed Transaction, as set forth therein. The purpose of this Certification is to comply with condition number 23 of the Order. I therefore certify, on behalf of the Petitioners in the above-captioned matter, that, based upon information of which I am personally aware or which I have reviewed, with respect to the Bergen System,

- a. said cable television system is in compliance with Article 820 of the National Electrical Code;
- b. sufficient funds will be available to fund all outstanding network extensions, rebuilds, upgrades or other construction commitments arising from such cable television system's Primary Service Area, Certificates of Approval, municipal consents, letters of intent or other orders or similar agreements, including but not limited to the Board Order in Docket No. CO15091102 and documentation provided subsequent thereto;
- c. billing records are available for all customers of such system, the Board and the Office of Cable Television & Telecommunications for three previous years in accordance with N.J.A.C. 14:18-3.7; and

- d. the Bergen System is and will remain compliant with Emergency Alert System ("EAS") obligations imposed by the Federal Communications Commission on digital programming services, effective December 31, 2013, and will retain the current levels of EAS functionality as provided or otherwise required under the State Operational Plan.

I hereby certify that the foregoing statements are true to the best of my information, knowledge and belief. I am aware that if any of the foregoing statements made by me are willfully false, I may be subject to punishment.
