Dear Secretary Asbury,

Enclosed for filing please find a revised copy of SUEZ Water Toms River, Inc.'s Distribution System Improvement Charge calculation for the July 1, 2016 through December 31, 2016 DSIC Recovery Period. The rates from this surcharge went into effect on March 1, 2017 on Rate Schedule No. 7.

The revised schedules reflect the elimination of certain projects totaling \$85,526 from page 8 of 11. Also revised was the Accumulated Depreciation and Accumulated Deferred Taxes which can be found in response to RCR-DSIC-2. These two revisions result in total DSIC revenues of \$749,882. However as shown on page 6 of 11, the rates that the parties agreed to produce \$756,092. This difference of \$6,210 will be reflected as a reduction in the next six month surcharge.

All schedules that have changes from the original filing have a revised date.
Please advise if you need additional information.
