Dear Ms. Mitchell:

On March 29, 2017, South Jersey Gas Company (Company) filed a notice with the Board of Public Utilities (Board) seeking authorization for the sale of real property to the South Jersey Transportation Authority for a sum total of \$5,000. The notice is required pursuant to N.J.A.C. 14:1-5.6(d)4, which provides that utilities may enter into such transactions, upon not less than 30 days' notice to the Board, provided that the property is not used by or useful to the utility and that the book cost and sale price are not in excess of \$500,000.

This letter is to acknowledge that, after review of the notice, the proposed sale as described in the Company's filing is deemed to be in the ordinary course of business under N.J.A.C. 14:1-5.6(d). Accordingly, pursuant to N.J.A.C. 14:1-5.6(e), enclosed is a certified true copy of the notice.



TO: THE HONORABLE COMMISSIONERS OF THE BOARD OF PUBLIC UTILITIES

South Jersey Gas Company (sometimes hereinafter referred to as "SJG" or the "Company"), a public utility corporation of the State of New Jersey, with its principal office at One South Jersey Plaza, Fulsom, New Jersey, hereby provides this Notice pursuant to N.J.A.C. 14:1-5.6(d) and (e), that it intends to sell a portion (.8964 acres) of the total 1.8952 acre real property located on Tilton Road, Block 1333, Lots 1 & 2 in Hamilton Township, Atlantic County, New Jersey (the "Property") to South Jersey Transportation Authority ("SJTA" or the "Purchaser"). In support hereof, South Jersey states as follows:

A. BACKGROUND

1. Purchaser proposes to acquire .8964 acres of the Property in order to maintain the Runway Protection Zones for the Atlantic City Airport. Absent SJG's agreement to sell, SJTA advised that it would proceed with eminent domain proceedings.
