On September 27, 2017, pursuant to the Board of Public Utilities (the "Board")' Decision and Order Adopting Initial Decision and Stipulation of Settlement (the "Order") in the above captioned matter, Atlantic City Electric Company ("ACE" or the "Company") filed tariff sheets that were consistent with the results of the Proof of Revenues and Rate Design attached to the Order. The tariff sheets included other language changes that were reviewed by Board Staff, the Division of Rate Counsel, and all parties to the proceeding. As required by the Order (page 6), the tariff pages bore an effective date of October 1, 2017.

If has come to the Company's attention that two of the tariff pages contained within that filing - the Second Revised Sheets replacing First Sheet No. 50 (Rider RP, Redevelopment Program Service) and First Sheet No. 51 (Rider SCD, Small Commercial Redevelopment) - did not reflect the most current, agreed-upon changes. As such, ACE refiles herewith an original and ten conformed copies of corrected Sheets No. 50 and 51. The tariff sheets contain all language changes agreed upon by the parties and continue to bear the October 1, 2017 effective date.
