
Dear Board Secretary:

The New Jersey Division of Rate Counsel ("Rate Counsel") reviewed the above referenced Petition of CenturyLink Communications, LLC ("CLC, and/or "Petitioner") dated November 17, 2017, seeking the New Jersey Board of Public Utilities' ("Board") approval to participate in financing totaling \$9.945 billion acquired in connection with the CenturyLink/Level 3 Communications, Inc., ("CTL/L3") merger approved under Board Order dated August 23, 2017.<sup>1</sup> On December 21, 2017, Rate Counsel filed comments not objecting to Board approval of the Petitioners request. On February 1, 2018, Petitioners filed a Letter Amendment and attachments with the Board with copy to Rate Counsel seeking to expand the financing petition by an additional \$300 million and include an additional financing participant.<sup>2</sup> Rate Counsel submits the additional comments for the Board's consideration.

Rate Counsel incorporates by reference the comments filed with the Board on December 21, 2017. Petitioners have provided additional information in support of the expanded proposed financing arrangement as required under *N.J.S.A. 48:3-7*, *-9* and *-10*, *N.J.S.A. 48:2-51.1*, and *N.J.A.C. 14:1-5.9*, to ensure the debt is made according to law and serves a beneficial purpose.<sup>3</sup> Accordingly, for the reasons herein stated and heretofore addressed by Rate Counsel in its December 21, 2017 filing, Rate Counsel does not oppose the Board's grant of Petitioners' requests under the Verified Petition and Amendment thereto. Thank you for your attention in this matter.
