## TO: THE HONORABLE COMMISSIONERS OF THE BOARD OF PUBLIC UTILITIES

1. This petition presents the request of Pivotal Utility Holdings, Inc. d/b/a Elizabethtown
Gas for the New Jersey Board of Public Utilities ("Board") to approve a municipal consent renewing
Elizabethtown's franchise ("Municipal Consent") in the Town of Newton ("Town"), Sussex County, New
Jersey. N.J.S.A. 48:2-14 requires Board approval of a franchise granted by a municipality to a public
utility subject to the Board's jurisdiction. The Municipal Consent renewing Elizabethtown's franchise in
the Town complies with all statutory and administrative requirements necessary for approval. The
Board's approval of the franchise is necessary and proper for the public convenience and properly
conserves the public interests.

- 1. By this petition, Pivotal Utility Holdings, Inc. d/b/a Elizabethtown Gas ("Elizabethtown" or "the Company"), hereby requests that the New Jersey Board of Public Utilities ("BPU" or "Board") pursuant to N.J.S.A. 48:2-14 and N.J.A.C. 14:1-5.5 approve the renewal of the franchise granted by the Town of Newton, Sussex County, New Jersey ("Town"). In support of its petition, Elizabethtown states the following:

- 3. Elizabethtown is a corporation duly organized under the laws of the State of New Jersey and is a public entity engaged in the distribution and transportation of natural gas subject to the jurisdiction of the Board. The Company's principal place of business is located at 520 Green Lane, Union, New Jersey 07083. Elizabethtown distributes natural gas and provides transportation service at retail to approximately 291,000 residential, commercial and industrial customers in Hunterdon, Mercer, Middlesex, Morris, Sussex, Union, and Warren counties.
- 4. Elizabethtown currently provides natural gas service within the Town and serves approximately 2,811 customers, consisting of 2,300 residential and 511 commercial customers. Elizabethtown has the capacity necessary to ensure the continuation of its natural gas service and does not foresee any concerns regarding its ability to meet the existing and future demands of the Town.
- 5. Pursuant to an Ordinance adopted on or about September 3, 1946, the Town consented to: (1) the Company furnishing natural gas service in the Town; and (2) the Company's use of the streets (the "Original Consent"). See September 3, 1946 Ordinance attached hereto as Exhibit A.
- Pursuant to Ordinance No. 2018-5, adopted March 12, 2018, the Town acknowledged the 6. Original Consent and renewed the Town's consent and permission to Elizabethtown to lay and construct its pipes and mains and related appurtenances and facilities within the streets, alleys, squares, and public spaces within the Town for a period of fifty (50) years. See Ordinance No. 2018-5 attached hereto as Exhibit B.
- 7. A letter accepting the terms and conditions of Ordinance No. 2018-5 pursuant to N.J.S.A. 48:3-16 is attached as Exhibit C and a proposed notice of public hearing is attached as Exhibit D.
- N.J.S.A. 48:2-14 requires Board approval of a franchise granted by a municipality to a public utility subject to the Board's jurisdiction. The franchise, which is the subject matter of this

petition, complies with all statutory and administrative requirements necessary for approval. The Board's approval of the franchise is necessary and proper for the public convenience and properly conserves the public interests.

WHEREFORE, Elizabethtown respectfully requests that the Board:

- (1) Approve the municipal consent renewing the franchise granted to Elizabethtown by the Town of Newton pursuant to Ordinance No. 2018-5; and
- (2) Provide any other relief deemed just and equitable.
