Dear Secretary Camacho-Welch:

This letter is on behalf of Rutgers, the State University of New Jersey, Princeton University, Johanna Foods, Inc., Phillips 66 Company, and Cogen Technologies Linden Venture, L.P. (the "OIW Coalition"), who are all intervenors in the New Jersey American Water Company (NJAW or Company) pending base rate case in OAL Docket No. PUC 14251-2017 S (NJAW Rate Case). We are writing to address an apparent intention by the Company to seek to implement a provisional rate increase pursuant to N.J.A.C. 14:1-5.12(e) through (k). By letter to the Board dated April 18, 2018, the Division of Rate Counsel ("Rate Counsel") informed the Board of the Company's intention and requested that the Board (1) prohibit the Company from implementing provisional rates until the Board has completed its review, should the Company in

fact seek to implement provisional rates, and (2) direct the Company to continue rate case settlement negotiations in good faith.

The OIW Coalition supports Rate Counsel's request, for the reasons Rate Counsel has given in its letter. In addition, Rate Counsel notes that the Company filed on September 15, 2017 for increase of approximately \$129.3 million per year, or about 17.54%. However, that filing occurred before the enactment of the federal Tax Cuts & Jobs Act of 2017 and the Board's subsequent order to the State's utilities with revenues greater than \$4.5 million to reduce rates on an interim basis effective April 1, 2018 to reflect the Act's reduction in the corporate income tax rate.² Thus, the Company currently has in effect provisional rates per the Board's direction.

Any further filing by the Company to revise its current provisional rates must also be subject to requirements of the Tax Act Order. Thus, the Company should be made to show that any noticed revision to its current interim rates complies with the Tax Act Order. The Board should have opportunity to review the Company's filing and order an evidentiary hearing be held if factual or other issues presented warrant same with respect to demonstrated compliance with the Tax Act Order.

We appreciate the opportunity to submit the OIW Coalition's position on this matter.
