Dear Secretary Camacho-Welch:

Please accept this letter on behalf of Petitioners in lieu of a formal response to Public Service Electric and Gas Company's ("PSE&G") June 22, 2018 Motion to Intervene in the above proceeding.

Petitioners of course do not deny that PSE&G is entitled to be heard with respect to Petitioners' requested waiver of a PSE&G tariff provision. However, Petitioners submit that the Motion to Intervene is unnecessary.

Petitioners initially served PSE&G because they are seeking a waiver of a PSE&G tariff provision. As a party "against whom a petition is directed," PSE&G had a clear right under N.J.A.C. 14:1-6.1(a) to file an answer to the petition. While such an answer was due within 20 days after service, N.J.A.C. 14:1-6.2(a), Petitioners do not object to treating PSE&G's motion as its late-filed answer.

Of course, neither a respondent nor an intervenor should be allowed to prevent the Board's consideration of the petition in a meaningful way. Construction of Petitioners' project is already under way, and a timely ruling by the Board is crucial. Therefore, even if the Board is inclined to grant the Motion to Intervene, it should only do so conditioned upon such intervention not delaying the proceeding to a point where it becomes moot.


