On January 31, 2018, the New Jersey Board of Public Utilities ("Board") issued an Order ("January 31, 2018 Order") which established a proceeding for all affected utilities to consider the implications of the 2017 Tax Cuts and Jobs Act, and in particular to implement interim rates effective April 1, 2018, until a final Board review is complete. The January 31, 2018, Order also established a procedural schedule for motions to intervene, discovery, technical conferences, filing of comments, and finally settlement conferences on May 31, 2018.

I am in receipt of your correspondence, dated June 21, 2018, wherein you requested the Board defer acting on these matters until such time a stipulation of settlement is submitted to the Board. Your request for a deferral of these matters without date was rejected by the Board. You are directed to provide Staff with specific details of your proposal to refund overcharges, the reasons you are asking for the deferral as well as when you will have the information necessary to calculate the ADIT amounts.
