CONSENT IN THE BOROUGH OF : PETITION

WEST CAPE MAY :

TO THE HONORABLE COMMISSIONERS OF THE BOARD OF PUBLIC UTILITIES:

By this Petition, South Jersey Gas Company ("South Jersey" or the "Company"), hereby requests that the New Jersey Board of Public Utilities ("BPU" or the "Board") pursuant to *N.J.S.A.* 48:2-14 and *N.J.A.C.* 14:1-5.5 approve the municipal consent granted by the Borough of West Cape May, Cape May County, New Jersey (the "Borough"). In support of its Petition, South Jersey states the following:

BACKGROUND

- 1. South Jersey is a regulated public utility engaged in the transmission, distribution, transportation and sale of natural gas in its defined service territory within the State of New Jersey. As such, South Jersey is subject to the jurisdiction of the Board. Within its service territory, the Company services approximately 386,000 customers.
- 2. South Jersey currently provides natural gas service within the Borough and serves approximately 903 residential customers and 50 commercial customers. South Jersey anticipates customer growth within its defined service territory to be approximately 1% annually and for the next 3-5 years.
- South Jersey has the capacity necessary to ensure a continuation of its natural gas service and does not foresee any concerns regarding its ability to meet the existing and future demands of the Borough.

4. Moreover, the Borough is serviced by South Jersey's Cape May Division customer service center located at 1708 Route 9 North, Swainton, New Jersey 08210. The Cape May Division will continue to serve South Jersey's customers within the Borough for the foreseeable future. No modifications to the location or hours of operation of the center are proposed by virtue of this Petition.

MUNICIPAL CONSENT

- 5. On or about July 1, 1969, pursuant to ordinance, the Borough provided consent to New Jersey Natural Gas: (1) to furnish natural gas service in the Borough; and (2) for New Jersey Natural Gas' use of the streets (the "Original Consent"). *See* July 1, 1969 Ordinance attached hereto as Exhibit "A".
- 6. By Order, dated September 29, 1983, the BPU approved the sale by New Jersey Natural Gas of all of the easements, rights of way, franchises, etc. in its Cape May County municipalities to South Jersey Gas. This order assigned the Original Consent to South Jersey Gas. See September 29, 1983 Board Order attached hereto as Exhibit "B".
- 7. Pursuant to *N.J.S.A.* 48:3-15, the portion of the Original Consent applicable to the Company's use of the streets is set to expire on July 1, 2019. Specifically, *N.J.S.A.* 48:3-15 provides, in relevant part, that "the board or body of such municipality authorized to grant consent may, by ordinance and not otherwise, grant for a period not exceeding fifty years, the right to use the streets petitioned for."
- 8. By virtue of this fifty (50) year statutory limitation, South Jersey obtained the renewed consent of the Borough applicable to its use of the streets. Pursuant to Ordinance No. 543-18, the Borough acknowledged the Original Consent and granted exclusive consent and permission to South Jersey to lay and construct its pipes and mains and related appurtenances and

facilities within the streets, alleys, squares and public places within the Borough for a period of

fifty (50) years. See Ordinance No 543-18 attached hereto as Exhibit "C".

9. By letter to the Borough dated July 13, 2018, South Jersey accepted and agreed to

the terms and conditions of such municipal consent pursuant to N.J.S.A. 48:3-16. A true and

correct copy of the Company's July 13, 2018 correspondence is attached hereto as Exhibit "D".

MISCELLANEOUS

10. A proposed public hearing notice is attached to this Petition as Exhibit "E". A copy

of this notice will be served on the Clerk of the Borough and the Clerk of the Board of Chosen

Freeholders.

11. N.J.S.A. 48:2-14 requires Board approval of a municipal consent granted by a

municipality to a public utility subject to the Board's jurisdiction. The consent, which is the subject

matter of this Petition, complies with all statutory and administrative requirements necessary for

its approval. The Board's approval of the consent is necessary and proper for the public

convenience and properly conserves the public interests.

WHEREFORE, South Jersey Gas respectfully requests that the Board grant the following:

1. Approve the municipal consent granted to South Jersey by the Borough; and

2. Provide any and other further relief deemed just and equitable.
