Please accept this letter on behalf of Jersey Central Power & Light Company ("JCP&L") in response to the motion to intervene in the above-referenced matter by the New Jersey Large Energy Users Coalition ("NJLEUC").

JCP&L takes no position on the NJLEUC motion to intervene at this time, because NJLEUC's motion does not identify any NJLEUC members that are currently JCP&L customers. NJLEUC's asserted interests in this matter derive entirely from the alleged status of its members as JCP&L customers. (See NJLEUC Motion, ¶¶ 1, 2, 5, 7, 8.) If NJLEUC demonstrates that its members include current JCP&L customers, JCP&L would not oppose the motion to intervene. Accordingly, JCP&L requests that the Board require NJLEUC to file and serve on JCP&L a list of members that are currently JCP&L customers.
