On September 26, 2018, Jersey Central Power & Light Company, Atlantic City Electric Company, Public Service Electric and Gas Company and Rockland Electric Company (collectively, the "EDCs") submitted revised tariff sheets and supporting exhibits ("EDC Tariff

Filing"). The EDC Tariff Filing incorporates changes to the PJM Open Access Transmission Tariff ("OATT") pursuant to a Federal Energy Regulatory Commission ("FERC") Order issued on May 31, 2018, in FERC Docket No. EL05-121-009 ("7th Circuit Settlement Order"). As set forth in the EDC Tariff Filing, PJM implemented changes to its OATT, effective July 1, 2018, on a going-forward basis. As a result, as set forth in the EDC Tariff Filing, Transmission Enhancement Charges in Schedule 12 of the PJM OATT have been adjusted to reflect the revised cost allocation.

As noted in the EDC Tariff Filing, Basic Generation Service ("BGS") suppliers began paying these revised transmission charges for transmission service effective July 1, 2018, pursuant to the PJM OATT changes implementing the 7th Circuit Settlement Order. In the EDC Tariff Filing, the EDCs seek authority from the Board to remit payment to suppliers for the increased charges they incur.

ExGen owns approximately 33,300 megawatts of generation, including nuclear, fossil, hydroelectric, solar, landfill gas, and wind generation assets. In addition, ExGen markets wholesale energy and capacity products to municipal, cooperative, and investor-owned utilities, retail suppliers, retail energy aggregators, merchant participants, power marketers, and major commodity trading houses. ExGen, individually or through its subsidiaries, has participated in the competitive BGS auction procurement processes and is a BGS supplier in New Jersey. As such, ExGen is subject to the Transmission Enhancement Charges in Schedule 12 of the PJM OATT.

ExGen therefore has a substantial interest in this matter and will be significantly affected by the outcome. ExGen's interest is sufficiently different from that of any other party so as to

add measurably and constructively to the scope of the case and that interest cannot be represented by any other party.

WHEREFORE, ExGen respectfully request the BPU grant this motion to intervene in this proceeding.
