Dear Judge Gertsman:

As previously discussed with your Honor, the parties in the above matter intend to circulate a Stipulation disposing of all but one issue by close of business today. The parties will request that your Honor adopt the stipulation, issue a partial initial decision, and submit the decision to the Board, pursuant to N.J.A.C. 1:1-12.5(e) for disposition.

With respect to the record in this matter, your honor initially asked New Jersey American Water ("Company" or "NJAWC") to indicate which parts of the record should remain with the Office of Administrative Law for disposition of the remaining issue. However, NJAWC has indicated and Board Staff and Rate Counsel agreed that due to the intertwinement of issues in the record physically parsing it would be difficult and impractical. Therefore, it is respectfully requested that your Honor transmit the entire record to the Board of Public Utilities ("Board"). Once the Board has issued its decision regarding the



Stipulation and initial decision, the Board will retransmit the record to the OAL.

If your honor wishes to discuss this issue further, the parties are available to discuss via phone.
