Petitioner, Service Electric Cable TV of New Jersey, Inc. ("Company" or "Petitioner"), a corporation of the State of New Jersey, having offices at 320 Sparta Avenue, Sparta, New Jersey, pursuant to N.J.S.A. 48:5A-1 et seq., and N.J.A.C. 14:17-6.9, hereby petitions the Board of Public Utilities ("Board") for the renewal of its Certificate of Approval ("COA") to own, operate, extend, and maintain a cable television and cable communications ("CATV") system in the Borough of Andover ("Borough"), County of Sussex, in accordance with the Borough's grant of Municipal Consent. In support thereof, Petitioner states as follows:

1. Petitioner is currently the holder of a Municipal Consent Ordinance adopted by the Borough granting Petitioner the right to construct and operate a CATV system in the Borough.
2. Petitioner is currently the holder of a Certificate of Approval granted by the Board, dated June 23, 2004, which grants the Petitioner a franchise period of fifteen (15) years from the date of issuance, with an automatic renewal provision for a term of ten (10) years thereafter pursuant to N.J.S.A. 48:5A-19 through -25 ("Current COA"). Exhibit A.

3. Petitioner filed an Application for Renewal of Municipal Consent ("Application") to own, operate, extend, and maintain a CATV system in the Borough, on or about September 14, 2018. Exhibit B.

4. After due consideration, Petitioner and the Borough have elected and otherwise consented to forego the Municipal Consent process and proceed with the automatic renewal set forth in the Current COA.

5. Petitioner respectfully petitions the Board to issue a Renewal Certificate of Approval to enable the Company to continue providing efficient and effective service to the residents of the Borough of Andover, County of Sussex.

6. In support of its petition, Petitioner respectfully relies upon the executed Application for renewal of Municipal Consent previously submitted to the Borough, with all annexed exhibits, attached hereto as Exhibit B.
