This Confidential Information is indicated with gray shading. The Confidential Information identifies specific substations, circuits and relays where work will be performed in the JCP&L Reliability Plus Projects. This information is highly sensitive and confidential because disclosure of this information could provide individuals information that could jeopardize the security and reliability of the electric distribution system.

- 3. N.J.S.A. 47:1A-1.1 exempts from the definition of a government record, and deems to be confidential information: "trade secrets and proprietary commercial or financial information obtained from any source," "energy or security information or procedures for any buildings or facility which, if disclosed, would jeopardize security of the building or facility or persons therein," and "security measures and surveillance techniques which, if disclosed, would create a risk to the safety of persons, property, electronic data or software."
- 4. The Confidential Information is highly proprietary commercial information and highly sensitive security information. Disclosure of the Confidential information would harm JCP&L and the public by providing individuals key information regarding equipment locations that affect the security of the electric distributions system.
- 5. JCP&L takes measures to ensure the Confidential Information remains safeguarded from public disclosure. JCP&L limits distribution of the Confidential Information to those employees, attorneys and consultants that have a need to work with it in connection with the pending matter. Further, JCP&L pursues confidentiality protection, such as entering the Agreement of Non-disclosure with the parties to this proceeding, and filing the Schedules in redacted form to protect the material from public disclosure. Here, the Company redacted the Confidential Information in the Schedules it originally filed with the Board and only provided the Confidential Information to those parties that executed the Agreement of Non-disclosure.

6. The Confidential Information is not contained in materials routinely available to

the public. Nor is it routinely available to other governmental entities, unless confidentiality

protection is first sought.

7. The Confidential Information should be treated as proprietary and confidential for

an indeterminate amount of time.

8. JCP&L notes that the public is not unduly impacted by Confidential treatment of

the Confidential Information, since much of the information in the Schedules is public and set

forth in the redacted version of the Schedules attached to the Stipulation, and JCP&L has

disclosed the limited Confidential Information to Staff and Rate Counsel subject to a Non-

disclosure Agreement.
