Re: Network Billing Systems, LLC Name Change Notification

Dear Secretary Camacho-Welch:

Network Billing Systems, L.L.C. dba Fusion dba Solex (“NBS”) hereby notifies the New Jersey Board of Public Utilities (“Board”) that the Company is changing its name from Network Billing Systems, L.L.C. to **Fusion LLC**, effective June 17, 2019.¹ Evidence of the Company’s New Jersey Department of Treasury name registration is attached.

The Company maintains authority to provide local exchange and interexchange telecommunications services throughout the State of New Jersey² The Company provides service exclusively to commercial subscribers. This change in corporate name is for branding purposes only and will have no effect on the services offered to New Jersey subscribers. The Company respectfully requests that the Commission amend its records to reflect the Fusion LLC name, as appropriate.

On December 13, 2018 NBS notified the Board of the Company’s election to de-tariff its New Jersey retail telecommunications services effective January 1, 2019, pursuant to the N.J.S.A. §48:2-21.1.9. The Company has amended its service guide to reflect the Company’s new name and posted same on its web site at <http://www.fusionconnect.com/tariffs>. No other amendments have been made.


