Good afternoon (evening), my name is Danielle Lopez, Assistant General State Regulatory Counsel for PSEG. I am pleased to represent Public Service Electric and Gas Company ("PSE&G") at this public hearing. PSE&G is New Jersey's largest utility, serving approximately 2.2 million electric customers and 1.8 million gas customers in a territory that extends from the northern to the southern parts of the state. It is my pleasure to provide you and the public in attendance here today with an overview of the Company's petition to modify its Non-Utility Generation Charge rate.

PSE&G's Non-Utility Generation Charge ("NGC") was established pursuant to the Electric Discount and Energy Competition Act of 1999 ("EDECA"), and was revised in a series of proceedings in 2002-2003. The Company's most recent NGC case was concluded by the Board's May 31, 2017 Order in Docket No.

on a typical residential electric customer that uses 740 kilowatt-hours during a summer month and 6,920 kilowatt-hours annually would be an increase of \$0.68, or approximately 0.05%, based upon current delivery rates and Basic Generation Service Residential Small Commercial Pricing (BGS-RSCP) in effect April 18, 2019 assuming that the customer received BGS-RSCP service from PSE&G.

TAKE NOTICE that, Public Service Electric and Gas Company ("Public Service", "the Company") filed a Petition with the New Jersey Board of Public Utilities ("Board", "BPU") in April 2019 requesting a resetting of the Company's Electric Non-utility Generation Charge ("NGC"). If approved, this filing would increase rates to be paid by the Company's electric customers by \$8.93 million annually. These changes are the result of adjustments in the electric NGC (which recovers Non-utility Generation above market costs). The proposed electric NGC charge, if approved by the Board, is shown in Table # 1.

The approximate effect of the proposed increase on typical electric residential monthly bills, if approved by the Board, is illustrated in Table # 2.

Based on the filing, a typical residential electric customer using 740 kilowatt-hours per summer month and 6,920 kilowatt-hours on an annual basis would see an increase in the annual bill from \$1,258.84 to \$1,260.40, or \$1.56 or approximately 0.12%.
