New Jersey Natural Gas Company (“NJNG” or the “Company”), hereby petitions the New Jersey Board of Public Utilities (“BPU” or “Board”) pursuant to *N.J.S.A. 48:2-14* and *N.J.A.C. 14:1-5.5* to approve the franchise granted by the Borough of Red Bank, Monmouth County, New Jersey through Resolution No. 19-77. In support of its petition, NJNG states the following:

2. NJNG is a corporation duly organized under the laws of the State of New Jersey and is a public utility engaged in the distribution and transportation of natural gas subject to the jurisdiction of the Board. The Company’s principal place of business is located at 1415 Wyckoff Road, Wall, New Jersey 07719. NJNG distributes natural gas and provides transportation service at retail to over half a million residential, commercial and industrial customers in Monmouth, Ocean, Morris, Middlesex and Burlington counties.

4. NJNG is currently providing natural gas service within the Borough of Red Bank in Monmouth County.
5. NJNG's current franchise with the Borough of Red Bank expired on March 17, 2019. On March 27, 2019, the Borough of Red Bank, by Resolution, renewed NJNG's franchise for a period of fifty (50) years. A copy of the Resolution (to be effective upon approval of the Board) is attached hereto as Exhibit A to this petition. By letter to the Borough of Red Bank, dated April 26, 2019, NJNG accepted and agreed to the terms and conditions of such Resolution pursuant to *N.J.S.A. 48:3-16*, which acceptance letter is attached as Exhibit B to this petition. A proposed Notice of Municipal Consent hearing is attached to this petition as Exhibit C. A copy of this petition also has been served on Pamela Borghi, RMC, CMR, PIO, Borough Clerk of the Borough of Red Bank.
6. *N.J.S.A. 48:2-14* requires Board approval of a franchise granted by a municipality to a public utility subject to the Board's jurisdiction. The franchise, which is the subject matter of this petition, complies with all statutory and administrative requirements necessary for its approval. The Board's approval of the franchise is necessary and proper for the public convenience and properly conserves the public interests.

WHEREFORE, New Jersey Natural Gas Company respectfully requests that the Board grant the following:

- (1) Approve the franchise granted to New Jersey Natural Gas Company by the Borough of Red Bank through Resolution No. 19-77; and
- (2) Provide any other relief deemed just and equitable.



**A RESOLUTION AUTHORIZING RENEWAL OF THE FRANCHISE
AGREEMENT WITH NEW JERSEY NATURAL GAS COMPANY**

WHEREAS, New Jersey Natural Gas Company has heretofore been granted a franchise and consent to lay, maintain and operate gas facilities in the Borough of Red Bank; and

WHEREAS, New Jersey Natural Gas Company is desirous of obtaining a franchise and consent of the municipality to continue serving the municipality.

NOW, THEREFORE, BE IT RESOLVED, that the Borough of Red Bank hereby consents and authorizes New Jersey Natural Gas Company to lay, maintain and operate for a period of fifty (50) years from the date hereof, its conductors, mains and pipes together with all appurtenances thereto, in, under and over all the public streets, alleys, squares and public places in the Borough of Red Bank for the purpose of conducting, transmitting and distributing gas or any mixture of gases of various types, including natural gas, upon the following terms and conditions and rules, regulations and ordinances of the Borough of Red Bank:

1. That New Jersey Natural Gas Company shall agree that, in all cases in which street openings or excavations are made for the purposes aforesaid, the pavement and surface of the streets, alleys, squares or roadways shall be restored to the same condition as existed prior to the opening thereof, and in accordance with Borough Ordinances; and
2. That New Jersey Natural Gas Company shall conduct the work or the laying or maintaining of gas pipes therein in a careful and prudent manner; and
3. That New Jersey Natural Gas Company shall safeguard the public interest in continuous and uninterrupted service at and after the expiration of the term of the grant; and
4. That New Jersey Natural Gas Company shall maintain its property in good order throughout the full term of the grant; and
5. That New Jersey Natural Gas Company shall continuously afford safe, adequate and proper service at just and reasonable rates.

BE IT FURTHER RESOLVED, that this franchise consent, upon approval of the Board of Public Utilities of the State of New Jersey, shall supersede the Resolution granted by the Borough of Red Bank on March 17, 1969; and

BE IT FURTHER RESOLVED, that New Jersey Natural Gas Company shall file with the clerk of this municipality within sixty (60) days from the date hereof, its acceptance of the terms and provisions of the franchise consent herein granted and its agreement to be bound by the terms and provisions thereof; and

BE IT FURTHER RESOLVED, that this resolution shall not become effective unless and until it is approved by the Board of Public Utilities of the State of New Jersey.
