PSE&G is also engaged in the purchase, distribution, and sale of natural gas for more than 1,800,000 customers located within the State of New Jersey.

7. Due to PSE&G's experience in the electric industry, its participation in this proceeding is likely to add constructively to the proceeding.


8. PSE&G will abide by the schedule set for this proceeding, to the extent one has been entered.
