## **SUPPLEMENTAL NOTICE OF TECHNICAL CONFERENCE<sup>1</sup>**

### **Investigation of Resource Adequacy Alternatives** **Docket No. EO20030203**

Pursuant to the “Open Public Meetings Act”, N.J.S.A. 10:4-6 et seq., Staff of the New Jersey Board of Public Utilities (“NJBP” or “Board”) offers this Supplemental Notice to provide parties the agenda and details for its [September 18, 2020 Technical Conference](#).

By [Order dated March 27, 2020](#), the Board initiated this proceeding, directing Staff to conduct the investigation through technical conferences, legislative-type hearings, and written comments. In a [Public Notice dated July 14, 2020](#), Staff informed parties that the technical conference will be held on September 18, 2020 and provided opportunity for self-nominations.

The purpose of this technical conference is further examination of whether New Jersey can achieve its long-term clean energy and environmental objectives under the current resource adequacy paradigm. Due to public health and safety concerns, this technical conference will be held via webinar, and will include opportunity for public questions and comments. All panels will be moderated by NJBP Staff. The public is encouraged to submit post-technical conference comments by October 2, 2020.

Parties that wish to participate as a panelist during the technical conference should submit self-nominations to [board.secretary@bpu.nj.gov](mailto:board.secretary@bpu.nj.gov), with a subject line of “Nominations for Resource Adequacy Technical Conference.” Nominees should identify the panels on which they wish to serve. Nominations must be submitted by August 28, 2020 at 5 p.m. ET. Parties who self-nominated before this notice may (but are not required to) supplement their nominations with a panel request. NJBP will inform selected nominees of their position on a panel by September 4, 2020.
