**AFFIDAVIT IN SUPPORT OF MOTION

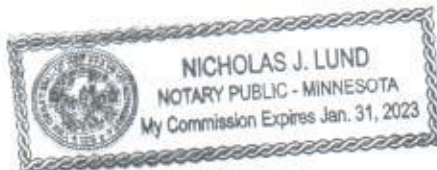
7. If this application to appear *pro hac vice* is granted, I agree to:
