Proposed Changes to Procedural Schedule**

Dear Secretary Camacho-Welch:

Please accept this letter in lieu of a more formally styled motion for a modification to the Procedural Schedule in the above referenced matter.

Atlantic City Electric (“ACE”) recently amended its petition through its rebuttal testimony without advance notice to the other parties. Therefore, the intervenors were deprived of the opportunity to address ACE’s revised program offerings 7 through 9 in their pre-filed testimony. In order to provide a fair opportunity for intervenors to develop a comprehensive record, ChargePoint, Rate Counsel, EVgo, and Electrify America respectfully request that Commissioner Chivukula, the assigned Hearing Officer, adopt the following changes to the existing Procedural Schedule. Tesla and Greenlots do not object to these requested modifications to the procedural schedule.

The following proposed changes to the procedural schedule would allow intervenors an opportunity to submit pre-filed sur-rebuttal testimony regarding ACE’s recent changes to its proposed offerings 7 through 9 and require ACE to update its discovery responses prior to the evidentiary hearings. Board Staff has informed us that Commissioner Chivukula is available on the proposed new evidentiary hearing dates, and ACE has agreed to these new dates as well. ACE has also agreed to provide updates to its discovery responses (if needed) between November 4th and November 6th.
