

The undersigned represents Aqua New Jersey, Inc. (“Aqua” or the “Company”), the Petitioner in the above referenced matter. As an update to the Company’s March 31, 2020 letter, it remains the Company’s intention to make the Tax Repair Election described in Paragraph 13(a) of the Stipulation of Settlement approved by the Board of Public Utilities (the “Board”) on May 28, 2019. As previously reported, the Company’s internal analysis regarding the Tax Repair Election has been delayed due to a variety of circumstances including the COVID-19 crisis. At this time, Aqua anticipates that its analysis will be finalized and the Company will make its required filing with the Internal Revenue Service in 2021. The Company appreciates the understanding and forbearance of Staff and Rate Counsel as Aqua works to complete its analysis in these challenging times.
