After conferring with the parties to this proceeding, the Company provides this letter to respectfully request a suspension of the Procedural Schedule embodied in the December 15, 2020 Prehearing Order Setting Procedural Schedule and Ruling on Motions to Participate and Intervene and for Admission Pro Hac Vice in this matter. Specifically, the Company's request includes suspension of the deadline for the filing of Intervenor/Rate Counsel testimony. The purpose of the suspension is to facilitate on-going settlement discussions.
