CERTIFICATION OF MICHAEL A. CHOWANIEC

- I, Michael A. Chowaniec, being of full age, hereby certify to the best of my knowledge as follows:
- 1. I am Vice President, State Government Affairs, of Charter Communications, Inc. ("Charter"), indirect parent company of Spectrum New York Metro, LLC, f/k/a Time Warner Cable New York City LLC ("SNYM" and, together with Charter, "Petitioners"), and Spectrum New Jersey, LLC ("SNJ"). SNJ operates a cable television system serving fourteen municipalities in northern New Jersey, to wit:

Cliffside Park, Edgewater, Englewood, Englewood Cliffs, Fairview, Fort Lee, Leonia, Little Ferry, Moonachie, Palisades Park, Ridgefield, Ridgefield Park and Teterboro in Bergen County, and Guttenberg in Hudson County (collectively, the "Bergen System").

2. On October 14, 2020, the Board of Public Utilities ("Board") issued an Order in the above-captioned matter (the "Order") authorizing a certain internal reorganization of SNYM and Charter. Condition number 16) of the Order requires SNYM to certify to the Office of Cable

Television and Telecommunications ("OCTV&T") no later than January 25, 2021 that (a) the Bergen System is in compliance with Article 820 of the National Electrical Code; (b) all Board-ordered requirements or conditions arising out of any Offers of Settlement and Certificates of Approval have been or shall be timely satisfied; (c) sufficient funds will be available to fund all extensions, rebuilds, upgrades, or other construction commitments arising from a system's Primary Service Area, Certificates of Approval, Municipal Consents, Letters of intent, or other Orders or Agreements; and (d) the billing records for all New Jersey cable television customers of any cable television system under ownership or control of either Petitioner are available and can be provided to the OCTV&T in accordance with N.J.A.C. § 14:18-3.7 (collectively, the "Certification Requirements"). The purpose of this Certification is to comply with these Certification Requirements.

- 3. I therefore certify, on behalf of the Petitioners and SNJ that, based upon information of which I am personally aware, which I have reviewed, or which have been conveyed to me by persons with relevant knowledge:
 - a. the Bergen System is in substantial compliance with Article 820 of the National Electrical Code;
 - b. all Board-ordered requirements or conditions pertaining to the Berger System and arising out of any and all Offers of Settlement and Certificates of Approval have been or are being satisfied within the time frame set forth therein;
 - c. sufficient funds will be available to fund all outstanding Bergen System network extensions, rebuilds, upgrades, or other construction commitments arising from a system's primary Service Area, Certificate of Approval, Municipal Consent, Letters of Intent or other Orders or agreements, including but not limited to the Board Order in Docket No. CO20100636 and documentation provided subsequent thereto; and

d. billing records are available for all customers in the Bergen System, and Petitioners are able to provide the Board and OCTV&T with copies of such records for three (3) years

in accordance with N.J.A.C. § 14:18-3.7.
