
Dear Secretary Camacho:

On behalf of New Jersey-American Water Company, Inc. (“NJAWC” or “Company”), I write regarding the stipulation of settlement (“Stipulation”) in the above-referenced base rate case at OAL Docket No. PUC 17894-2019 S, Agency Docket No. WR19121516. On October 22, 2020, The Honorable Jacob S. Gertsman issued an Initial Decision approving the Stipulation. Late yesterday, NJAWC discovered a typographical error in the Stipulation. Specifically, in paragraph 4 the Company incorrectly transcribed the long-term debt ratio as 45.54%. The correct number is 45.44%. The typographical error does not flow through to any other number in the Stipulation or any of the Stipulation’s Schedules.

The Company respectfully requests that the Stipulation be corrected on the record. The Company has consulted with counsel for all parties, and they consent to this request (*see* attached correspondence).

Late yesterday, the Company discovered a typo in the rate case Stipulation that we believe needs to be corrected. In paragraph 4, the long-term debt ratio was incorrectly transcribed as 45.54%. The correct number, as reflected in the Company's 12&0 update is 45.44%. As you can see, the long-term debt and common equity ratios incorrectly total 100.1%.

To correct the error we would like to send an updated Stipulation to ALJ Gertsman by correcting only this page and retaining all of the original signatures. I would have preferred to speak with some of you personally regarding this, but given the timing (I believe Judge Gertsman's Initial Decision is imminent) I believe we should do this ASAP.
