On March 2, 2021, a prehearing conference was held in the above matter. Representatives from all parties and interveners were present, and engaged in a discussion on the outstanding issues, schedule, and nature of the proceeding. Based upon that conference, and with consideration of the issues and discussions raised there, I **HEREBY ORDER** the following:

1. Live cross examination is available to all parties
2. Order of witnesses is as follows:
  - a. PSEG
  - b. Market Monitor
  - c. Rate Counsel
  - d. Staff
3. Order of Cross Examination is as follows:

- a. PSEG
  - b. Market Monitor
  - c. P3
  - d. NJLEUC
  - e. Rate Counsel
  - f. Staff
  - g. Commissioners
4. All documents previously submitted through the application and discovery process, including the public hearing testimony, are in the record as evidence, based upon consent of all parties
  5. Any party wishing to use a document not already in the record must share that document with all parties no later than 4 p.m. on Thursday, March 4, 2021
  6. Those parties and participants that have access to confidential information and wish to be allowed into the confidential question session must RSVP by no later than 12 noon on Friday, March 5, 2021

Additionally, I note that an application for admission *pro hac vice* had been filed on behalf of Matthew Price, Esq., representing PSEG. Based upon review, the consent of all parties, and the associated filings, it appears that:

1. Mr. Price is a member in good standing admitted to practice in the District of Columbia;
2. Mr. Price has significant experience representing the interests of energy companies, and this proceeding involves a complex field of law, such that good cause is shown; and
3. Mr. Price has paid to the New Jersey Lawyers' Fund for Client Protection the fees required by R. 1:20-1(b).

Accordingly, and based upon the above, I **HEREBY FIND** that Mr. Price satisfies the conditions for admission *pro hac vice*, and I am satisfied that he submitted to the Board proof of payment to the New Jersey Lawyers' Fund for Client Protection of the fees required by R. 1:20-1(b) and 1:28-2. Therefore, I **HEREBY ORDER** that Mr. Price is **HEREBY ADMITTED** to practice before the Board *pro hac vice* in this matter, subject to the following conditions:


1. Mr. Price shall abide by the Board's rules and all applicable New Jersey court rules, including all disciplinary rules;
2. Mr. Price shall consent to the appointment of the Clerk of the Supreme Court as agent upon whom service of process may be made for all actions against them that may arise out of his participation in this matter;
3. Mr. Price shall notify the Board immediately of any matter affecting his standing at the bar of any other jurisdiction; and
4. Mr. Price shall have all pleadings, briefs and other papers filed with the Board signed by an attorney of record authorized to practice in this State, who shall be held responsible for them and for the conduct of this cause and the admitted attorney therein.

This ruling is subject to ratification or modification by the Board, as it deems appropriate during the proceedings in this matter.

This Order shall be effective on March 4, 2021.
