Dear Secretary Camacho-Welch:

In its Order dated October 2, 2020 (“October 2 Order”) in the above-referenced proceedings, the Board of Public Utilities (“Board”) directed Atlantic City Electric Company, Jersey Central Power & Light Company, Rockland Electric Company, and Public Service Electric and Gas Company (collectively, the “EDCs”) to present in a report to the Board recommendations for the implementation of consolidated billing (“Consolidated Billing Report”), by no later than February 26, 2021. In its Order dated January 7, 2021 in the above-referenced proceedings, the Board supplemented the October 2 Order by directing “the EDCs to consider multiple options for the implementation of consolidated billing for community solar and to incorporate a robust stakeholder process.”

To date, the EDCs have been working diligently with Board Staff to draft a proposed Notice (including questions) seeking stakeholder input on community solar consolidated billing. Due to the timing of preparing and issuing the Notice soliciting stakeholder input; the time required to conduct a robust stakeholder process; the complexity of consolidated billing (including the need to coordinate the EDCs information technology efforts); delays caused by the ongoing COVID-19 pandemic; and the cost of implementing consolidated billing; the EDCs require additional time to prepare a meaningful Consolidated Billing Report to the Board.

Accordingly, the EDCs collectively hereby request that the current February 26, 2021 due date for the EDC's submission of the Consolidated Billing Report be extended to May 28, 2021. The EDCs also propose the Board establish the other milestone dates set forth below. This schedule will provide adequate time for stakeholder input and for the preparation of a detailed and informative Consolidated Billing Report.

EDCs file Report	May 28
