BY COMMISSIONER ROBERT M. GORDON:

I. **BACKGROUND**

On February 19, 2020, the New Jersey Board of Public Utilities (“Board”) ordered three (3) of the New Jersey’s electric distribution utilities to file, or update previously filed, petitions for an Advanced Metering Infrastructure (“AMI”) program by August 27, 2020.¹ In compliance with the AMI Order, on August 27, 2020, Jersey Central Power & Light Company (“JCP&L” or “Company”) filed a petition seeking approval of a \$733 million AMI Program, including an associated cost recovery mechanism pursuant to N.J.S.A. 48:2-21 and N.J.S.A. 48:2-21.1 (“Petition”).

By Order dated September 23, 2020, the Board determined that the Petition should be retained by the Board for hearing, and pursuant to N.J.S.A. 48:2-32, designated myself, Commissioner Robert M. Gordon, as the Presiding Commissioner with the authority to rule on all motions that arise during the pendency of these proceedings and modify any schedules that may be necessary

to secure a just and expeditious determination of the issues.² Further, the Board directed that any entity seeking to intervene or participate file the appropriate application with the Board by October 14, 2020. Any party wishing to file a motion for admission of counsel, pro hac vice, was requested to do so concurrently with any motion to intervene or participate.

On January 13, 2021, I issued a Prehearing Order with Procedural Schedule and rulings on Motions to Intervene and Participate ("January 2021 Order"). Throughout February 2021, the parties engaged in discovery and multiple settlement discussions. As a result, on February 26, 2021, JCP&L filed an electronic communication requesting suspension of the Procedural Schedule embodied in the January 2021 Order to facilitate ongoing settlement discussions. JCP&L also noted that the parties reserved their right to request a further/amended Procedural Schedule at a later date, in the event one was required.

II. **DISCUSSION AND FINDINGS**

I reviewed JCP&L's February 26, 2021 communication requesting a suspension of the Procedural Schedule as the parties work towards a possible settlement. With the consent of the parties, I **HEREBY SUSPEND** the Procedural Schedule set forth in the January 2021 Order in this matter.

I **HEREBY DIRECT** that this Order be posted on the Board's website.

This provisional ruling is subject to ratification or other alteration by the Board as it deems appropriate during the proceedings in this matter.
