Please be advised that I am in receipt of your correspondence dated March 10, 2021, and Rate Counsel's objection thereto dated March 12, 2021, regarding the above referenced matters.

On December 18, 2020 I entered three (3) separate Prehearing Orders wherein I issued a Revised Procedural Schedule providing that post evidentiary hearing briefs are due on March 26, 2021, and reply briefs are due on April 9, 2021.¹ I agree with Rate Counsel that the information you provided on behalf of PSEG Nuclear, LLC in your March 10,
