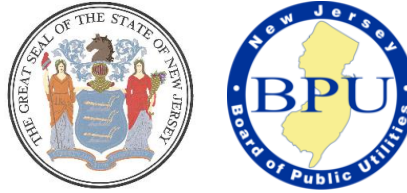

NOTICE¹

Pursuant to the Open Public Meetings Act, N.J.S.A. 10:4-6 to -21, the New Jersey Board of Public Utilities (NJBPUB or Board) hereby gives notice of a Special Public Meeting to be held on Wednesday, July 28, 2021 at 10:00 a.m. to consider the following matters:

CLEAN ENERGY

- A.** Docket No. QO20020184 – In the Matter of Solar Successor Incentive Program Pursuant to P.L. 2018, c.17.

The Board will consider implementing a new Successor Solar Incentive Program 30 days after the issuance of this order that would provide a series of tiered incentives to net metered residential solar projects, net metered non-residential solar projects of 5 MW or less, community solar projects, as well as incentives to projects located on contaminated lands or landfills on an interim basis.

- B.** Docket No. QO19010068 – In the Matter of a New Jersey Solar Transition Pursuant to P.L. 2018, c. 17 – Closure of Program to New Registrants.

The Board will consider closing the Transition Incentive Program 30 days after the issuance of this order.

- C.** Docket No. QO21030667 – In the Matter of the Release of the Solar Successor Competitive Administrator Request for Quotation (RFQ) – **Executive Session.***

The Board will consider the selection of a consultant to help design and implement the Competitive Solar Incentive Program, which will provide incentives to grid supply projects and net metered non-residential solar projects over 5 MW.

- D.** Docket No. QX21060944 – In the Matter of a Rulemaking Proceeding to Define the Class I Renewable Portfolio Standard Cost Cap Pursuant to P.L. 2018, c. 17. *

The Board will consider proposing a rule to implement the requirements of Section 38(d)(2) of the Clean Energy Act of 2018, as amended, which establishes a cost cap on certain Class I renewable energy incentives.
