CERTIFICATION

I, MICHAEL J. BAKER, do hereby certify as follows:

1. I am an attorney-at-law of the State of New Jersey, a partner in the law firm of Hoagland, Longo, Moran, Dunst & Doukas, LLP, attorneys for Intervenor, Township of East Brunswick Water Utility (hereinafter the "Utility"), and am fully familiar with this matter.
2. I am familiar with the facts and circumstances concerning this matter and I make this Certification in support of the Utility's Notice of Motion to Intervene in this action.
3. The Utility is a corporate public body of the State of New Jersey, duly organized under and pursuant to the provisions of N.J.S.A. 40:14B-1 et. seq. The Utility maintains an office at 25 Harts Lane, East Brunswick, New Jersey 08816, State of New Jersey.
4. The Utility is not an initial party in this proceeding, but, nonetheless, will be substantially, specifically, and directed affected by the outcome of this proceeding.
5. The Utility is a contract customer of Middlesex Water Company ("Middlesex"). Service charges for water treated and pumped by Middlesex to the Utility are calculated under and pursuant to Middlesex's Rate Schedule No. 6, entitled "Special Contract Service." Under the contract currently in effect between the Utility and Middlesex, the Utility receives a minimum of 2.9 billion gallons of water each year from Middlesex. Based upon a preliminary review of the Petition filed by Middlesex and the supporting documents, it appears that the increase sought by Middlesex for bulk water service supplied pursuant to contract approximates 37.79%.
6. The Utility's interests relate to and are affected by every aspect of the Petition filed by Middlesex and the Utility intends to cross-examine witnesses and present direct evidence and testimony regarding all issues.
7. Approximately 55,000 persons within the Utility's service area will be affected by the new rates proposed by Middlesex and said customer's interests, and the interests of the

Utility in this proceeding will not be adequately protected by any of the other parties. As a large use contract customer, the Utility's interest is significantly different from the majority of Middlesex's other customers. Therefore, it is essential that the Utility be permitted to intervene for the purpose of representing its own interests.
