Pursuant to the Open Public Meetings Act, N.J.S.A. 10:4-6 et seq., the New Jersey Board of Public Utilities (NJBPU or Board) hereby gives notice of a series of Public Stakeholder Meetings to discuss the **[New Jersey Electric Vehicle Infrastructure Ecosystem 2021 - Medium and Heavy Duty Straw Proposal](#)** (Straw Proposal) released by Board Staff on June 30, 2021.

NJBPU Staff invites interested parties and members of the public to provide comments on this Straw Proposal, which will help inform Staff's recommendations to the Board for developing a pathway forward for the build-out of medium and heavy duty electric vehicle (EV) charging infrastructure in the state, and the roles of private and public entities in this endeavor.

In accordance with the 2019 Energy Master Plan, New Jersey needs to create a comprehensive EV ecosystem that ensures accessibility to EV charging infrastructure for businesses, as well as the general public. The development of minimum filing requirements for EV charging is crucial for the State, and Staff is seeking input from stakeholders, including New Jersey's consumers, employers, property owners, Electric Distribution Companies (EDCs), and investors. Many of the issues that this Straw Proposal seeks to explore include questions about who should construct, own, operate, and pay for the network necessary to make New Jersey a national leader in the adoption of EVs and associated EV infrastructure.

Staff is soliciting stakeholder input on the Straw Proposal through a series of virtual public meetings. The meetings include a variety of topic-specific panels detailed below, with panelists drawn from industry experts and others with knowledge of these topics. The technical conference-format will provide stakeholders the opportunity to hear from technical experts on each topic, then ask questions during the time allotted. There will also be one stakeholder meeting for general comments. Staff welcomes comments on all topics discussed in the Straw Proposal, both at the technical conferences as well as in written form.
