Dear Secretary Camacho-Welch:

Enclosed for filing by Butler Electric (the "Company"), please find the Company's filing in accordance with the Board of Public Utilities' Order in the above referenced Docket dated April 18, 2019.

In the legislation establishing the Zero Emissions Certificate Recovery Charge ("ZECRC") the New Jersey Electric Distribution Companies ("EDCs") were directed to return excess monies in each EDC's separate, interest bearing account to its retail distribution customers at the end of each energy year. In this filing, Butler Electric is proposing to refund the excess collections from Energy year 2021.

The Company is proposing to refund the excess ZECRC collection and corresponding interest over a twelve month period commencing January 1, 2022 via the previously established "Return of Excess Collections Credit Rate ("RECCR"), which is a component of the ZECRC and currently set at -\$0.000149 for 2021. The proposed RECCR is -\$0.000083 per kilowatt-hour (w/o SUT).

This filing includes the following:

- Attachment C Notice of Filing and Notice of Public Hearings

For Energy Year 2022 and going forward, Company will monitor the ZECRC excess collection balance and as it approaches zero, the Company proposes to file with the Board. Any excess balance remaining at that point will be included in the Company's next RECCR filing. The company is also proposing that if future RECCR adjustments are required, rate changes be handled via compliance filing, as

the credit will fluctuate between Energy Years. In both situations described above, the Company will make a compliance filing no later than 30 days prior to any change to the RECCR.

Furthermore, as directed by the Board's Order in Docket No. EO20030254, dated March 19, 2020, the Company hereby submits this filing via electronic delivery only to the Board Secretary, and will suspend submitting such filings as paper documents until the Board directs otherwise.

### Notice of a Filing and Notice of Public Hearings

PLEASE TAKE NOTICE that, in October 2020, Butler Electric (the "Company") filed with the New Jersey Board of Public Utilities (the "Board") seeking the Board's approval to refund excess Zero Emissions Certificate Recovery Charge ("ZECRC") collections over a twelve month period commencing January 1, 2021 via the "Return of Excess Collections Credit Rate ("RECCR") for the Energy Year 2019 "stub period" and Energy Year 2020. The Company is proposing a reduction in the RECCR to adjust the refund of excess collections from Energy Year 2021. As a result of this adjustment, the proposed RECCR would increase from (\$0.000149) per kilowatt-hour (w/o SUT) to (\$0.000083) per kilowatt-hour (w/o SUT).

Under the Company's proposal, a typical residential electric customer using 740 kilowatt-hours per month, and 6,920 kilowatt-hours on an annual basis, would see an increase in the annual bill from \$1,101.72 to \$1,102.32, or \$0.60 or approximately 0.05%.

The approximate effect of the proposed changes on typical electric residential monthly bills, if approved by the Board, is illustrated in Table #1.

Any rate adjustments with resulting changes in bill impacts found by the Board to be just and reasonable as the result of the Company's filing may be modified and/or allocated by the Board in accordance with the provisions of N.J.S.A. 48:2-21 and for other good and legally sufficient reasons to any class or classes of customers of the Company. Therefore, the described charges may increase or decrease based upon the Board's decision.
