VERIFIED PETITION

Sol CES Projects, LLC, a Delaware limited liability company having its principal place of business at 1101 Connecticut Ave, NW, 2nd Floor, Washington, DC 20036 ("Petitioner"), by its undersigned counsel, and pursuant to applicable rules of the New Jersey Board of Public Utilities ("Board"), hereby requests the Board to allow two solar energy projects being developed by Petitioner to be included in the Transition Incentive ("TI") program for such projects. Petitioner contends that it was unlawfully deprived of the opportunity provided by N.J.A.C. 14:8-10.4(e)(2) to remedy any incompleteness in its application within seven business days after notice of such incompleteness, notwithstanding the closure of the TI program. Such closure did not repeal the cited regulation, and indeed could not do so without a proper rulemaking proceeding, including notice in the New Jersey Register and opportunity for comment.

In support of this Petition, Petitioner states as follows:

I. <u>DESCRIPTION OF THE PETITIONER'S PROJECTS AND REGISTRATIONS</u>

Petitioner is an experienced solar system developer, having successfully constructed ten solar projects in New Jersey since 2016, with many more that are currently under development.

The projects at issue in this Petition were for two rooftop installations in Secaucus, New Jersey, for 1.320 MW DC and 1.070 MW DC, respectively (the "Projects"). Registrations for the Projects were uploaded by the Petitioner to the TI portal on August 26, 2021, one day before the announced closure of the TI program, along with fifteen other projects that were successfully uploaded by Petitioner and are not a matter of dispute here.

The regulations for the TI program identify eight specific items that must be included with each registration, and a ninth category of "any other data or information" necessary for a determination that the subject project will meet the requirements to earn Transitional Renewable Energy Certificates, or TRECs. N.J.A.C. 14:8-10.4(e)(1).

The alleged incompleteness for Petitioner's Projects was a two-page Milestone Reporting Form (the "Form"). At the time of registration, the Form is necessarily filled out with "TBD" entries at the beginning of a project. The purpose of the Form is to report updates on a quarterly basis after a project is accepted into the TI program and construction commences. The Form is, therefore, useful as a practical matter as a "placeholder" for projects post-approval. The Forms for Petitioner's Projects were prepared on August 24, 2021, before the filing of Petitioner's registrations, and signed on August 26, 2021, the day of filing. Copies of the metadata evidencing the date the Forms were completed are attached as **Exhibit A**, and the signed Forms are attached as **Exhibit B**.

For reasons that remain unclear, every *other* document in each directory was uploaded, but the two Milestone Reporting Forms apparently were not. Petitioner received notice from the Program Administrator ("Program Administrator") for New Jersey's Clean Energy Program ("NJCEP") on September 13, 2021, a full eighteen days after Petitioner's submission, that the

documents were missing and the Projects "deactivated". Copies are attached as **Exhibit C**. Upon receipt of the notices, Petitioner provided the Milestone Reporting Forms immediately and filed an appeal of the Program Administrator's decision on September 23, 2021. A copy is attached as **Exhibit D**.

The Program Administrator denied Petitioner's appeal on October 26, 2021, citing the Board's July 28, 2021 Order providing for the closure of the TI program, which Order stated that if a registration of an outstanding TI program project was not completed by August 27, 2021, the registration would be terminated. The email denying Petitioner's appeals is attached as **Exhibit E**.

The TI regulations make clear that "Board staff shall notify the registrant in writing of any deficiencies" and that any incomplete registrations "shall be remedied within seven business days after the required notice." N.J.A.C. 14:8-10.4(e)(2). Pursuant to the regulation, which has not been repealed, only after the registrant has been afforded the seven day opportunity to cure will the failure result in cancellation of the registration process. Ibid. The Board's Order closing the program effective on August 27, 2021, did not and could not mean that the rules for the TI program were repealed on that date. Such action requires a formal rulemaking procedure including notice in the New Jersey Register and opportunity for public comment. N.J.A.C. 1:30-5.2; N.J.A.C. 1:30-5.4. Therefore, the procedures available for curing allegedly incomplete applications must still be recognized.

Moreover, even assuming that a repeal by Board Order, rather than formal rulemaking, of the seven day opportunity to cure required by N.J.A.C. 14:8-10.4(e)(2) was valid, relaxation of a hyper-technical application of the Order in the very narrow circumstance where a registration was timely filed but simply missing one document is warranted in order to obtain a fair result. The degree of economic hardship that Petitioner will suffer if it has to abandon the Projects will

be significant. Moreover, the Petitioner submitted its registrations on time, and the omission of a single document was either a technical issue or, at worst, merely inadvertent. <u>Cf. N.J.A.C.</u> 14:1-1.2 (providing for a waiver from a rule for good cause and in the interest of securing a just determination).

III. PUBLIC INTEREST CONSIDERATIONS

Grant of this Petition will serve the public interest of New Jersey because Petitioner's Projects are not viable under the Successive Solar Incentive, or SUSI, program and Petitioner will not be able to go forward with the Projects absent their eligibility for the TI program.² This outcome would be in direct contravention to New Jersey's stated goal of reaching 100% clean energy by 2050.

² Rooftop projects such as these have had the incentive reduced from \$152.00 to \$90.00. This explains the tremendous surge in registrations that were pursued by Petitioner and other developers in August 2021.

IV. CONCLUSION

For the foregoing reasons, Petitioner submits that the public interest, convenience, and

necessity would be furthered by grant of this Petition. Petitioner asks the Board to allow its

Projects to participate in the TI program and to grant such other relief as may be just and proper.







This letter is intended to serve as Sol Systems' formal request that the New Jersey Board of Public Utilities (BPU) accept application NJSTRE1547531927 and NJSTRE1547531974, attached and originally signed and uploaded on August 26, 2021, as complete applications and/or reinstate the applications with a 30-day extension to refile. Sol Systems greatly appreciates the time BPU staff has given so far in this process and we thank you for continued assistance.

Please find the original files Sol Systems uploaded on August 26, 2021 attached. We have also included the verification from DocuSign as to when all documents were signed. As we noted in our initial email outreach to BPU staff, all documents were completed before the transition REC program deadline and our team attempted to upload all required documents at the same time. In addition to these two applications, Sol Systems submitted 15 additional projects, which were all accepted and are moving forward. We followed the same process for application NJSTRE1547531927 and NJSTRE1547531974 as we did for the other 15 projects, but it appears that the Milestone Reporting Form file did not actually upload for these two applications.

As requested for this appeal, below are responses to each question, and all application files for both projects are attached.

1. The current application status (rejected/cancelled/expired/other)

• Application Numbers NJSTRE1547531927 **and** NJSTRE1547531974 are both currently listed as "NJ TI INCOMPLETE - FINAL (RESUBMISSION REQUIRED)" and deactivated per the September 13, 2021, emails from the TREC Transition Incentive Program.

2. A copy of the document from which you are appealing (e.g., rejection letter)

• Copies of both emails requesting resubmission are attached.

3. A detailed description of the events that led to the appeal request

- The September 13, 2021, emails were the first notification Sol Systems received that the applications were incomplete.
- After notification of each incomplete submission, we immediately re-submitted all supporting information, including Milestone Reporting Forms.



- Additionally, Andrew Williams, Vice President of Policy & Corporate Affairs for Sol Systems reached out on September 15, 2021 in an attempt to rectify the failed upload of these two otherwise-complete permit applications.
- On September 20, 2021, Mr. Williams was informed that an appeal is necessary for each.

4. An explanation as to why you think your appeal should be granted

- The completed Milestone Reporting Forms (attached) have a DocuSign timestamp signature of August 26, 2021, consistent with the date we made our application.
- The timestamps on the Milestone Reporting Forms clearly show that the forms were complete when the application was submitted.
- The rejection emails Sol Systems received on September 13, 2021, were the first indication we had that there was a problem; this appeal represents Sol's first formal opportunity to remedy.
- We realize that problems occur from time to time and especially in the remote work environment we all face during this extended global pandemic, but we respectfully request leniency from the BPU in this limited instance.
- Without the transition REC program, the two projects would not be able to move forward and therefore would also leave our customer with no clean energy option.

Dear Mr. Grin:

We have DENIED your appeal seeking to have the subject solar registrations reinstated in the now-closed Transition Incentive (TI) Program. Your argument is that the NJCEP online registration system "appears" to have not actually uploaded the required Milestone Reporting Forms (MRFs). We have denied the appeal essentially because an Order of the Board of Utilities (Board or BPU) requires us to deny it. However, we also note that the projects are probably eligible for the new Successor Program.

On July 28, 2021, the Board entered an Order providing for the closure of the TI Program and stating, in particularly relevant part: "Turning to ... the over one thousand projects that have remained in the status "Eligible for TI" since being transferred from the SRP in 2020, the Board ... ORDERS that if the registration of these projects is not completed by 11:59:59 p.m. on August 27, 2021, these registrations shall be terminated. The registrants, or other parties if applicable, may have the opportunity to register these projects in the Successor Program." I/M/O Order Closing the Transition Incentive Program to New Registrants, Docket No. QO19010068 (July 28, 2021), p.6. Your TI registration was, in fact, not completed by 11:59:59 p.m. on August 27, 2021 in that the MRFs were not actually uploaded as required.

In your appeal, you argue that there must have been a technical problem with NJCEP's IT system at the time you were submitting these applications on August 26, 2021 and that you and your client should not be penalized for a problem with NJCEP's system. The factual basis of your argument is that you had all the necessary documents in hand, followed your usual uploading and submission process, successfully submitted 15 other registrations on August 26, and were able to upload the MRFs immediately after being notified on or about September 13 that they were missing. However, you admit you "do not have technical evidence that identified the potential system failure to record the upload(s)." And, to the contrary, the available evidence is that the system was in fact operating normally on August 26 – on that day the Program Manager successfully accepted over 350 applications and its outside IT service provider has since confirmed that there were no problems with the system on August 26 (although there was a problem for approximately an hour early in the morning on August 27). In short, you have failed to demonstrate that it is more likely that that the failure to upload the required MRFs was the result of an IT failure on the part of the Program Manager

In sum, the Board Order requires the Program Manager to terminate any registration that was not complete on August 27, and yours were not complete on that date. Further, we are not at all sure the Board Order could be read as authorizing the acceptance of a registration that would have been completed but for a problem with NJCEP's online registration system, and, even if the Board Order could be so read, you have not made that "but for" showing. Finally, the denial of your requested relief is consistent with NJCEP's "literal, almost mechanical" application of NJCEP's rules related to its various solar program deadlines.

If you wish to pursue this matter further, you have the right to file a petition for a formal hearing with the New Jersey Board of Public Utilities pursuant to N.J.A.C. 14:1-1.
