In accordance with the Board of Public Utilities' ("Board") January 29, 2014, Order in the above-referenced matter, please accept this correspondence on behalf of Atlantic City Electric Company, Jersey Central Power & Light Company, Public Service Electric and Gas Company, and Rockland Electric Company (collectively, the "EDCs").

Pursuant to the January 29, 2014, Order, the Board approved National Economic Research Associates ("NERA") as the joint EDC Solar Renewable Energy Certificate ("SREC") Auction Manager for a two-year period, and thereafter until a subsequent auction manager is approved by the Board. Prior to the end of the two-year period, the Order further directed the EDCs to advise the Board and Rate Counsel whether NERA still meets the criteria established for the Auction Manager and whether they believe it is in the best interests of ratepayers to issue another RFP or extend the NERA contract. On October 23, 2015, again on December 21, 2017, and again on October 24, 2019, the EDCs advised the Board that NERA continued to meet the criteria established for the Action Manager and that NERA's management continued to be in the best interest of ratepayers. As a result, the EDCs renewed for two years the NERA Auction Manager contract, first effective February 24, 2016, then effective February 24, 2018, and then effective February 24, 2020.

The EDCs believe NERA has met and continues to meet the established criteria for Auction Manager and that it remains in the best interest of the ratepayers for the EDCs to work with NERA to explore another extension of the NERA contract.
