Pursuant to the interim e-filing procedures adopted by the Board of Public Utilities (the “Board”) on March 19, 2020 (the “Interim Procedures”), please find attached the Verified Petition and Verification (collectively, the “Petition”) of Comcast of Monmouth County, LLC (“Comcast”), along with a public version of Comcast’s Application for Renewal of a Certificate of Approval (the “Application”), in connection with the above referenced matter. The attached public Application has been redacted so as to protect certain confidential information contained therein, as described below.

In further support of the Petition, (i) a copy of this letter, (ii) the affidavit of Comcast’s Senior Director of Government and Regulatory Affairs, Robert D. Clifton (the “Affidavit”), and (iii) a confidential and unredacted version of the Application (the “Confidential Application”) have been filed electronically via the Board’s “Infoshare” e-filing portal, also pursuant to the Interim Procedures.

In accordance with N.J.A.C. 14:1-12 et seq., Comcast respectfully submits that certain designated information in the Confidential Application is proprietary commercial information and that the Confidential Application therefore does not constitute a government record under the New Jersey Open Public Records Act, P.L. 2001, c. 404 (N.J.S.A. 47:1A-1 et seq.), and is thus exempt from public disclosure. The Affidavit filed simultaneously herewith via the “Infoshare” portal substantiates Comcast’s request for confidential treatment.
