RESOLUTION OPPOSING ELIZABETHTOWN GAS COMPANY PETITION TO NEW JERSEY BOARD OF PUBLIC UTILITIES, DOCKET NO. GR21121254

WHEREAS, on December 28, 2021, Elizabethtown Gas Company (the "Company") filed a Petition with the New Jersey Board of Public Utilities (the "Board") under Docket No. GR21121254, which Petition was subsequently transmitted to the New Jersey Office of Administrative Law (the "OAL") as a contested case where it was docketed as PUC 00872-2022 N, seeking approval of a request to increase base tariff rates and charges for gas service, as well as implement other rate design and tariff revisions (the "Petition"); and

- WHEREAS, pursuant to the Petition, the Company also proposed to change its depreciation rates, and requested authorization to defer certain costs that are not reflected in the Company's base rate request for recovery in future proceedings; and
- WHEREAS, pursuant to the Petition, the Company proposed that these changes become effective January 28, 2022; and
- WHEREAS, the Board subsequently issued an order on January 26, 2022, suspending the effective date of the proposed rates and tariff revisions until May 28, 2022; and
- WHEREAS, the Petition filed by the Company reflected an increase in annual revenues of approximately \$76.6 million, or 19%; and
- WHEREAS, according to the Petition, the impact of the Petition on the bill of an average residential customer using 100 therms per month would be \$19.42 or 17.2%, and the actual percentage increase applicable to specific customers will vary according to the applicable rate schedule and the level of each customer's usage; and
- WHEREAS, the Company provides in the Petition that the proposed increase is predominantly the result of capital expenditures made or to be made by the Company related to system improvements and reliability since the Company's last base rate case; and
- WHEREAS, the Board has the statutory authority to establish the Company's rates at levels it finds just and reasonable as well as to establish the effective date of such rates, and therefore, the Board may establish the rates at levels and/or an effective date other than those proposed by the Company; and
- WHEREAS, due to the COVID-19 pandemic, the Board has scheduled virtual-telephonic public hearings on April 21, 2022 at 4:30 p.m. and 5:30 p.m. so that members of the public may present their views on the Company's Petition; and
- WHEREAS, members of the public may present their views to the Board on the Petition during the public hearing by dialing the toll-free telephone number and entering the passcode set forth in the Notice of Public Hearing on file with the City Clerk; and

WHEREAS, the Board will also accept written and/or electronic comments from members of the public, which will be made part of the final record of this proceeding, and such comments can be provided in accordance with the instructions set forth in the Notice of Public Hearing on file with the City Clerk.

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF PERTH AMBOY:

- 1. The aforementioned recitals are incorporated herein as though fully set forth at length.
- 2. The City Council of the City of Perth Amboy, County of Middlesex, State of New Jersey hereby opposes the Company's Petition seeking Board approval for increases in base tariff rates and charges for gas service.
- 3. The City Council hereby authorizes the City Clerk to transmit this resolution to Acting Board Secretary, Carmen Diaz, at the Board of Public Utilities, 44 South Clinton Avenue, 1st Floor, P.O. Box 350, Trenton, New Jersey 08625-0350 (board.secretary@bpu.nj.gov), with reference made to the name of the Petition and docket number as set forth herein.
