MOTION TO INTERVENE

Proposed Intervenors Township of Marlboro and Old Bridge Municipal Utilities Authority (collectively, "Proposed Intervenors"). Hereby move before the New Jersey Board of Public Utilities (the "Board") pursuant to N.J.S.A. 48:2-32.2 to permit Proposed Intervenors to join as Intervenors in the above captioned proceeding with all of those rights and obligations typically afforded to an intervernor in such proceedings. In support of its motion, the Proposed Intervenors state as follows:

1. On March 15, 2022, Middlesex Water Company ("Middlesex Water") initiated the above captioned proceeding by filing a Petition requesting approval to change the levels of its purchased water adjustment clause (PWAC) to recover increased purchased water costs, together with deferred costs, PWAC rate case expenses and associated gross receipts and franchise taxes. Middlesex Water seeks an increase in its rate for water services amounting to approximately \$3,725,535, or 3.62% in

- additional annual revenue. The increase in rates is proposed to become effective for services rendered on a date listed for as soon as possible.
- Middlesex Water proposed PWAC increase represents an actual effective rate increase of approximately 3.49% for Marlboro Township Water Utility Department and 4.02% for the Old Bridge Municipal Utilities Authority.
- These rate increases are in addition to significant base rate increases already approved as the result of the Petitioner's May 19, 2021 petition in BPU Docket No. WR21050813.
- Middlesex Water provides water and wastewater services to Proposed Intervenors and residential, commercial and industrial users within Proposed Intervenors' municipal boundaries.
- 5. N.J.S.A. 48:2-32.2 provides in pertinent part that "[e]very municipality may intervene alone or jointly with another municipality or municipalities in any hearing or investigation held by the board, which involves public utility rates, fares or charges, services or facilities, affecting the municipality or municipalities or the public within the municipality or municipalities and may employ such legal counsel, experts and assistants as may be necessary to protect the interest of the municipality or municipalities or the public within the municipality or municipalities."
- Pursuant to N.J.S.A. 40A:65-1 et seq. Of the Joint Meeting Statute, a local unity authorized to enter into an agreement under Section 4 of P.K. 2007, c. 63
   (C. 40A:65-4) may do so by adoption of a resolution.
- 7. The Proposed Municipal Intervenors have previously adopted resolutions authorizing the joint representation in this proceeding. (Old Bridge Municipal Utilities Authority,

Resolution # M-46-21, Adopted June 16, 2021 and memorialized July 28, 2021 and Township of Marlboro Resolutions #2021-222 and 2021-275, adopted June 17, 2021 and August 19, 2021 and wish to continue this representation.

- 8. The Attorney Certification of Michael R. Burns is attached hereto certifying that the facts and statements herein are true and accurate to the best of his knowledge and belief.
